## The Thirteenth Annual North Carolina Workers' Compensation Educational Conference Monday - Wednesday October 13 - 15, 2008

The Industrial Commission and the International Workers' Compensation Foundation are jointly sponsoring an Educational Conference which is unique in North Carolina. ## Who Should Attend?

All employers, insurance adjusters, self-insurers, third party administrators, safety and human resource managers, plaintiff's and defense attorneys, paralegals, health care providers, mediators and medical and vocational rehabilitation providers are encouraged to attend.
