Your attention is directed to the Rules of the Industrial Commission as they apply to hearings before the Full Commission. All briefs or motions to the Commission should be submitted in triplicate.

For cases set on the attached calendar before the Full Commission on September 15, 19 & 21, 2005, all motions, requests for continuances, and telephone inquiries should be directed to the attention of Victoria Homick, Agency Legal Specialist to Commissioner Pamela T. The appropriate contact person varies with each calendar and will be identified as above.

Requests for continuances must be submitted at least two weeks prior to the date of hearing or oral argument may be waived in lieu of continuances for the requesting parties. Unexpected emergencies will be the exception. In the event a case is continued, the case will be heard before the same panel at a later date.
