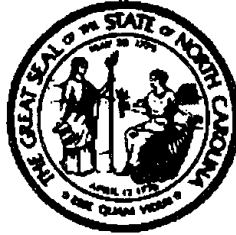

Your attention is directed to the new Rules of the Industrial Commission as they apply to hearings before the Full Commission. All briefs or motions to the Commission should be submitted in triplicate. In those cases in which a party represented by counsel has failed to timely file a brief with the Commission, oral argument may not be permitted by that party.

Requests for continuances must be requested at least two weeks prior to the date of hearing or oral argument may be waived in lieu of continuances for the requesting parties. Unexpected emergencies will be the exception. **However, in the event a case is continued, the case will be heard before the same panel on a later date.**
