Promoting Swifter Decisions at the Deputy Commissioner Level: The Pre-Trial Order

- Contents of Workers' Comp Pre-Trial Order
 - Statement confirming case ready for hearing (PTA)
 - Exhibits submitted via EDFP (required for Attorneys)
 - Stip Exhibit #1 PTA
 - Stip Exhibit #2 All other Exhibits (New filing requirements)
 - One hard copy to the Deputy at the beginning of the hearing
 - Filed via EDFP post-hearing w/in 2 days
 - Deposition Transcripts & Exhibits submitted electronically in <u>PDF</u> format via EDFP (Paperless)
 - Expert Witnesses & IME Testimony Listed and Scheduled ahead of hearing
 - Does not affect 04 NCAC 10A .0613 15 days
- Cautionary Instructions to Pro Se litigants

Promoting Swifter Decisions at the Deputy Commissioner Level: The New Post-Hearing Order

- Contents of Post-Hearing Order
 - Contentions, Briefs, Proposed O&As submitted electronically (PDF / MS Word format) via EDFP
 - Deposition Transcripts & Exhibits submitted electronically in <u>PDF</u> format via EDFP

 After the Order Closing the Record, Deputy Commissioner to file O&A within <u>90 Days</u>

Medical Motions at the Deputy Commissioner Level

- G.S. § 97-25 / 04 NCAC 10A .0609A
 - (Practice Tip: Read the above)
- Accepted Claims -> medical issues only
 - Form 60 Acceptance
 - Form 63 (1) w/o Form 61 within 90 days
 - Already adjudicated compensable
 - No issues of compensability
- Medical Issues Only
 - No mix and match
 - On the previously accepted body part (Wilkes)

Medical Motions

- Heard by Executive Secretary's Office
 - Administrative Medical Motions
 - Administrative Order filed within 30 Days
 - Notice of Appeal filed within 15 Days of receipt of Admin. Order
- Heard by Deputy Commissioner Section
 - FE Hearings Appeals of Administrative Orders
 - FE Hearings Requests for Expedited Hearings
 - Emergency Medical Motions (Non-Emergencies ref'd)
- EMM & Appeals are filed at <u>Medicalmotions@ic.nc.gov</u>
 - Not Filed Elsewhere
 - Not a Form 33
 - Appeals must identify the administrative order being appealed <u>and</u> state that the order was entered pursuant to G.S. § 97-25(f)(1).

75 Day Timeline for Medical Motions at DC Level

 Appeals of Executive Secretary Orders & Requests for Expedited Hearings – Subject to Full Evidentiary "Rocket" Docket:

- -5 Days from filing → Notice of Hearing
- -30 Days from filing → Hearing
- -60 Days from filing → Record closes
- -75 Days from filing → O&A filed

EMERGENCY Medical Motions at DC Level

- Emergency Medical Motions
 - -5 Days from filing → Order filed
 - -Must allege adverse consequences if relief not given emergently
- "Emergency" Medical Motions which are deemed not an emergency are referred to the Executive Secretary for an administrative ruling.
- Key Question before filing:
 - Are there significant adverse consequences that justify by-passing an evidentiary hearing?

Civil Contempt Hearings

- Read G.S. § 5A-21 through -25
- Incarceration for failure to comply with a Commission order. G.S. § 97-80
- Before filing Motion to Show Cause on a Discovery matter.
 - What is my goal?
 - Is there another remedy other than jail available? If so, consider filing a motion for that remedy.
